Introduction

Information Use

 - To send periodic emails or newsletters, as requested by the user.
 - To process transactions or fulfil orders, if applicable.
- b. Non-personal identification information may be used to analyze trends, administer the Website, track user movement, and gather demographic information for internal purposes.

c. IP Address:

 IP addresses is collected and processed temporarily for security monitoring, and are discarded once the security verification is completed.

Information Protection
